VALUATION DECLARATION: There are three (3) options available to cover loss or damage:

- 1. 60 cents per pound per article. This minimum coverage for lost or damaged items is based on 60 cents times the weight of the article. This coverage is provided at no additional charge. (Free of Cost)
2. Actual Cash Value. This option provides for lost or damage based on actual cash value, including depreciation, at the time of loss or damage, up to the total dollar amount of value declared by you.
3. Full Value Protection. This option provides for the lost or damaged items based on current replacement value at the time of loss or damage, up to the total dollar amount of valuation declared by you.

Basic Value Coverage (Free) _____ Actual Value Coverage (\$135) _____

Under this option, JSM assumes liability for no more than 60 cents per pound, per article. Loss or damage claims are settled based on the weight of the article multiplied by 60 cents per pound. For example, if a 10-pound stereo component valued at \$1,000 were lost or destroyed, JSM would be liable for no more than \$6.00 (10 pounds x 60 cents per pound).

We do not assume liability for boxes we did not pack, fragile items left unpacked, mechanical and electrical items (without evidence of external damage), items of exceptional value or "Risky Moves" include moving items through limited space (tight hallways and doorways) and moving unpacked fragile or particle board items. We only assume up to \$1000 maximum liability for floor damage occurrence
